EQUINE ACTIVITY
AGREEMENT AND RELEASE

In consideration of Tyler's Arena, Ltd. of 1054 S: Hollister Road, Ovid, Michigan 48866, hereinafter referred to as THE EQUINE ACTIVITY SPONSOR, permitting me to engage as an active participant in equine related activities, and

Understanding, acknowledging and agreeing that engaging in equine related activities could be hazardous and may result in injury, or death, and being aware that a horse may bite, or step on, or throw a rider to the ground, may jump on, or kick a person, and all of these activities and similar activities may result in injury or death.

I agree to assume all risks of injury arising out of participating in the equine related activities, either off or upon the premises of THE EQUINE ACTIVITY SPONSOR.

I release and agree not to sue THE EQUINE ACTIVITY SPONSOR, its agents, employees, servants, directors, officers, shareholders, or anyone connected with its association, including Thomas Tyler and Sharon L. Tyler, from any and all liability for any claim for injury, damages, costs or causes of action which I have or may have in the future as a result of injuries or damages sustained by me or incurred by me while participating in such equine activity, either off or upon the premises of THE EQUINE ACTIVITY SPONSOR.

I agree not to invite or permit any other person(s) to enter the premises or to engage in any equine activity as my guest. Any such participant shall be deemed a trespasser, not an invitee, unless such person(s) execute(s) an "Equine Activity Agreement and Release" with THE EQUINE ACTIVITY SPONSOR.

I further agree to indemnify THE EQUINE ACTIVITY SPONSOR, its agents, employees, servants, directors, officers, shareholders, or anyone connected with its association, including Thomas Tyler and Sharon L. Tyler, for any costs, expenses, damages or legal fees which may be incurred as a result of any breach or violation of this "Agreement and Release", if such breach results in injury or death to any person(s) engaging in such equine activity, without regard to whether such injury or death is alleged to have resulted from any alleged acts of negligence of THE EQUINE ACTIVITY SPONSOR, its employees, agents, servants, directors, officers, shareholders, or anyone connected with its association, including Thomas Tyler and Sharon L. Tyler.

Warning

Under the Michigan Equine Activity Liability Act, an equine professional is not liable for an injury to or the death of a participant in an equine activity resulting from an inherent risk of the equine activity (PA 351 of 1994).

It is mutually understood and agreed that the above release of liability constitutes a waiver of liability beyond the provisions of the Michigan Equine Activity Liability Act (1994 PA 351).

This Agreement and Release shall be interpreted under Michigan law.

If participant is under age 18, parent or legal guardian must sign this Agreement and Release.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to be on premises at Toms Western Store "Tyler Arena" I, on behalf of myself and any minor child/children for whom I have the capacity to contract, as well as any other individuals listed on the signed "Patron Entrance Form" for our family, hereby acknowledge and agree to the following:

1. I understand the hazards of the novel coronavirus ("COVID 19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.
2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in any events held at Tyler Arena Ltd.
3. I will utilize personal safety precautions suggested at Toms Western Store "Tyler Arena" per CDC guidelines.
4. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children for whom I have the capacity to contract as well as those I have listed on the ("Paton Entrance Form") the show staff volunteers, vendors, Toms Western Store "Tyler Arena", their employees, employees, affiliated parties and assigns (the "RELEASEES") from any liability related to COVID-19 which might occur as a result of my being on the premises and participating in the activities.
5. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, cost and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury or loss of items.

It is my express intent that the Waiver and Hold Harmless Agreement shall bind any assigns, heirs, and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of Michigan.

I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT OF THE PERMISSION GRANTED BY RELEASEES TO BE ON PREMISES.
